What is **Europass** ?



It is a portfolio of documents developed by the European Commission to support European citizens' mobility.

The Europass website, managed by Cedefop, was launched in 2005 and has received some **100 million** visits so far.

What is **the Europass CV** ?

It is the curriculum vitae layout recommended by the European Commission.

It helps students, workers and job-seekers to present their skills and qualifications in an effective and consistent way when applying for jobs or training opportunities.

What is **the Europass online editor** ?

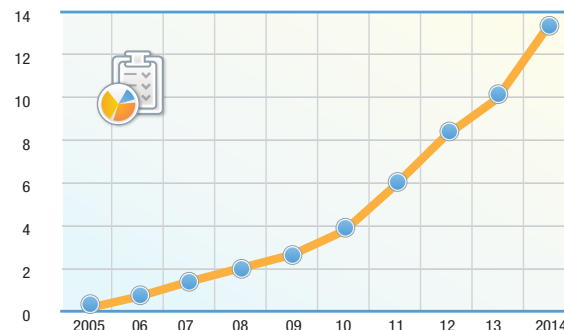


- The online editor enables end-users to create and update their CV online.
- It allows end-users to download the CV on their PC, send it by e-mail or export it to the Cloud.
- It is available in **27 languages**.
- It has an intuitive, user-friendly interface, optimised for both desktop and tablets.
- A cover letter can be created online and downloaded with the CV.
- Copies of degrees, certificates, etc. can be attached to the CV to create an electronic portfolio.
- Over **13 million** Europass CVs were generated online in 2014 and about **48 million** in total since launch.
